SECTION 4: First aid measures

4.1. Description of first aid measures

WEB TACK SPRAY ADHESIVE

General information	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
Inhalation	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. SECTION 7: Handling and storage

7.1. Precautions for safe handling

Usage precautions

For professional users only. Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Avoid exposing aerosol containers to high temperatures or direct sunlight. The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes.

Advice on general occupational hygiene

Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment.
