SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation

Get medical attention immediately. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Place unconscious person on their side in the recovery position and ensure breathing can take place. Loosen tight clothing such as collar, tie or belt.

Ingestion

Get medical attention immediately. In the unlikely event of ingestion GET medical attention immediately. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Place unconscious person on their side in the recovery position and ensure breathing can take place. Do not induce vomiting. Never give anything by mouth to an unconscious person. Promptly get affected person to drink large volumes of water to dilute the swallowed chemical.

Skin contact

Remove contamination with soap and water or recognised skin cleansing agent. Consult a physician for specific advice. Continue to rinse for at least 15 minutes and get medical attention. If adhesive bonding occurs, do not force skin apart. Promptly flush contaminated skin with water. Promptly remove clothing if soaked through and flush the skin with water.

Eye contact

Get medical attention immediately. Continue to rinse. Only remove contact lenses if the person is conscious, coherent and they can remove them themselves

Ingestion may cause severe irritation of the mouth, the oesophagus and the gastrointestinal tract. May cause stomach pain or vomiting. Swallowing concentrated chemical may cause severe internal injury.
